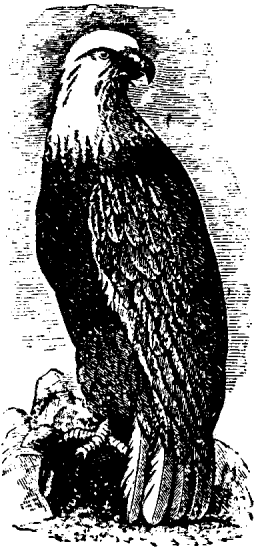

## Leonard Lake and Charles Ng:

### Anomalies and Suggested Explanations

This is the third article in a series in which I'm presenting some of my beliefs regarding Leonard Lake and Charles Ng. In this article, I've noted some of the anomalies that are associated with the situation and suggested some explanations for those anomalies. The anomalies didn't occur to me recently. I noticed them at the time that the situation was being reported, in 1985.

On page 5 is the fourth and final article in the Leonard Lake and Charles Ng series. In that article, I've presented the theory that supports my explanations of the anomalies. My next article, hopefully next month, will explain why I believe the situation represented by Leonard Lake and Charles Ng is related to the attacks of September 11, 2001.

### Anomaly Number 1: Suicide

Leonard Lake apparently carried cyanide capsules at all times. He had them handy when he was detained by the police and he used them to commit suicide while he was in custody. People in this country do commit suicide but they don't usually carry cyanide and use it when they've been detained by the police. Whatever somebody's done, the normal behavior in this country is to hire a lawyer.

It was alleged that Leonard Lake and Charles Ng had made a suicide pact. However, such agreements are usually just braggadocio and are unlikely actually to be honored. Charles Ng didn't honor the agreement, if it existed at all. As of this writing, he's still alive on death row.

It doesn't seem likely that Leonard Lake felt sufficiently guilty about his behavior to commit suicide. All manner of perverts generally pursue their pleasures regardless of whatever remorse they might experience. See the C. S. Lewis quote. When Leonard Lake took a suicide pill, it suggested to me that something more ominous than ordinary criminal activity was involved.

### Suggested Explanation

Leonard Lake committed suicide because the discovery of the nature of his activities would have caused him to be placed in a situation worse than anything that might result from conviction of a crime, however heinous. Whatever that situation might have been, it was sufficiently serious that Leonard Lake took a suicide pill to avoid it.

### Anomaly Number 2: Escape

Charles Ng walked away from the lumber yard in South San Francisco before the police arrived. Why would he assume that Leonard Lake would sit and wait for the police? How did he know that Leonard Lake would be apprehended? How did he know that his identity would be revealed? In other words, how did Charles Ng have any idea that the police would be looking for him? Somehow he knew because when the police arrived at his apartment, he was already gone.

How did Charles Ng, a man on foot with few resources, manage to evade a dragnet set up by Interpol, the FBI, the Royal Canadian Mounted Police, and Scotland Yard? How did he get all the way to Canada without being caught? The escape, as reported, doesn't make any sense.

### Suggested Explanation

Charles Ng knew that the authorities were going to be after him because he was told by someone. He evaded the dragnet and escaped to Canada because he had help.

### Anomaly Number 3: Cremation

From the accounts that I've read, at least some of the bone fragments that were found at the Wilseyville site were the remains of people who had been cremated. It takes a lot of fuel to cremate a human being so thoroughly that only bone fragments remain. I didn't find a description of the incinerator that was presumably used for the cremations so I can only speculate about the fuel that was used. If Leonard Lake and Charles Ng used gasoline, kerosene, or propane, then they had to buy and transport a lot of fuel. If they used wood, then they had to cut and transport a lot of wood. It seems unlikely that they would have had the resources required to dispose of bodies so thoroughly.

### Suggested Explanation

Leonard Lake and Charles Ng were supplied with all of the necessary resources by somebody else.

### Anomaly Number 4: Inconsistent Disposal

Some victims were buried casually. Those remains were relatively easy to discover and identify. Some victims were photographed or videotaped, leaving a record of their appearance. Other victims were processed in such a way that it would be difficult if not impossible to determine their identities or even the number of them. In many cases, it would be impossible even to discover the remains at all. Why the difference? Why would Leonard Lake and Charles Ng have exerted such effort to hide some victims and made so little effort to hide others?

### Suggested Explanation

The difference between the handling of the different categories of victims was the difference between business and pleasure. Leonard Lake and Charles Ng apprehended some victims themselves, for their own recreational purposes. They disposed of those victims casually. Some victims were supplied to them by someone else. They disposed of those victims very carefully.

### Anomaly Number 5: Number of Victims

The authorities estimated the total number of victims at 25 or 26. I believe that the number was much higher than that. Presented next are some reasons for my belief.

The authorities recovered a lot of bone fragments. Several quantities of such fragments were reported: 41 pounds, 45 pounds, and 50 pounds. I expect that it would take a lot of people to produce that weight in bone fragments. Some of the remains that were recovered had been strewn around the property. Some such discarded remains might have been eaten or carried away by local scavengers and thus not recovered. Therefore, the remains that were actually recovered might not represent all of the victims. There might be some truth to the account that some of the remains were fed to the chickens. That's another reason why the remains that were recovered might not represent the entire number of victims.

The known efforts of Leonard Lake and Charles Ng to acquire victims were limited to nearby neighbors, local people who were trying to sell things through want ads, stray acquaintances, people who wandered by for one reason or another, and that sort of thing. If Leonard Lake and Charles Ng had been obtaining their victims only from those local sources, then there would have been a cluster of disappearances in the vicinity of Calaveras County during 1984 and the first half of 1985. I examined data from The Doe Network website.<sup>1</sup> I've shown the data graphically on page 4. The counties for which I included data are listed on page 3. I chose those counties because they were all within about 120 miles of Calaveras County. I chose that distance because Leonard Lake and Charles Ng went about that far to get a vice. If they would go that far to get a vice then they would probably go that far to get victims.

The data don't show a significant increase in disappearances during the time that Leonard Lake and Charles Ng were obtaining victims. However, 25 or 26 victims, the official estimate, is larger than the total number of disappearances per year for all other causes combined for any year in that decade. If there had been a sufficiently large number of local disappearances in addition to the normal number of disappearances to account for the number of victims attributed to Leonard Lake and →

Charles Ng, using even the official estimate, then it would have been noted as a significant increase in the rate of disappearances. Authorities would have suspected the presence of a serial killer. No such occurrence of serial disappearances was noted. Thus, the victims could not have been taken from the local region. They must have been taken from a geographical area large enough that the disappearances were not recognized as being associated with one another.

To acquire victims from such a large region would have presented serious logistical problems for Leonard Lake and Charles Ng. First, they would have needed more secure transportation than vehicles that had belonged to missing persons, vehicles with incorrect license plates, or stolen vehicles. Remember, it was false ID and a vehicle registered to a missing person that were instrumental in the eventual capture of Leonard Lake. They would have needed to abduct people without attracting attention. That might be easily accomplished a few times, but not over a very large number of abductions. They would have needed to transport the abducted people securely over long distances, without anybody escaping or attracting attention. Even such a simple thing as getting people into and out of a public rest room without exposure would be risky.

To avoid the possibility of the abductions being associated with one another, they would have needed to find their victims in a geographical area that would be as large as the several adjacent states. They would necessarily be working in locations with which they were unfamiliar and which were probably well known to their intended victims.

Even if the official estimate is correct and they killed only 25 or 26 people over a period of about 17 or so months, then that still means that they located, abducted, transported, killed, and disposed of victims on the average of about one person every 2 or 3 weeks. If my hunch is correct, then they located, abducted, transported, killed, and disposed of victims on the average of at least one person every week. The financial burden in fuel alone would probably have been prohibitive.

Suggested Explanation

Except for victims that Leonard Lake and Charles Ng obtained for their own recreational purposes, the victims were supplied to them by someone else.

Theory

My theory regarding the identity of the source of the help that was available to Leonard Lake and Charles Ng is presented on page 5.

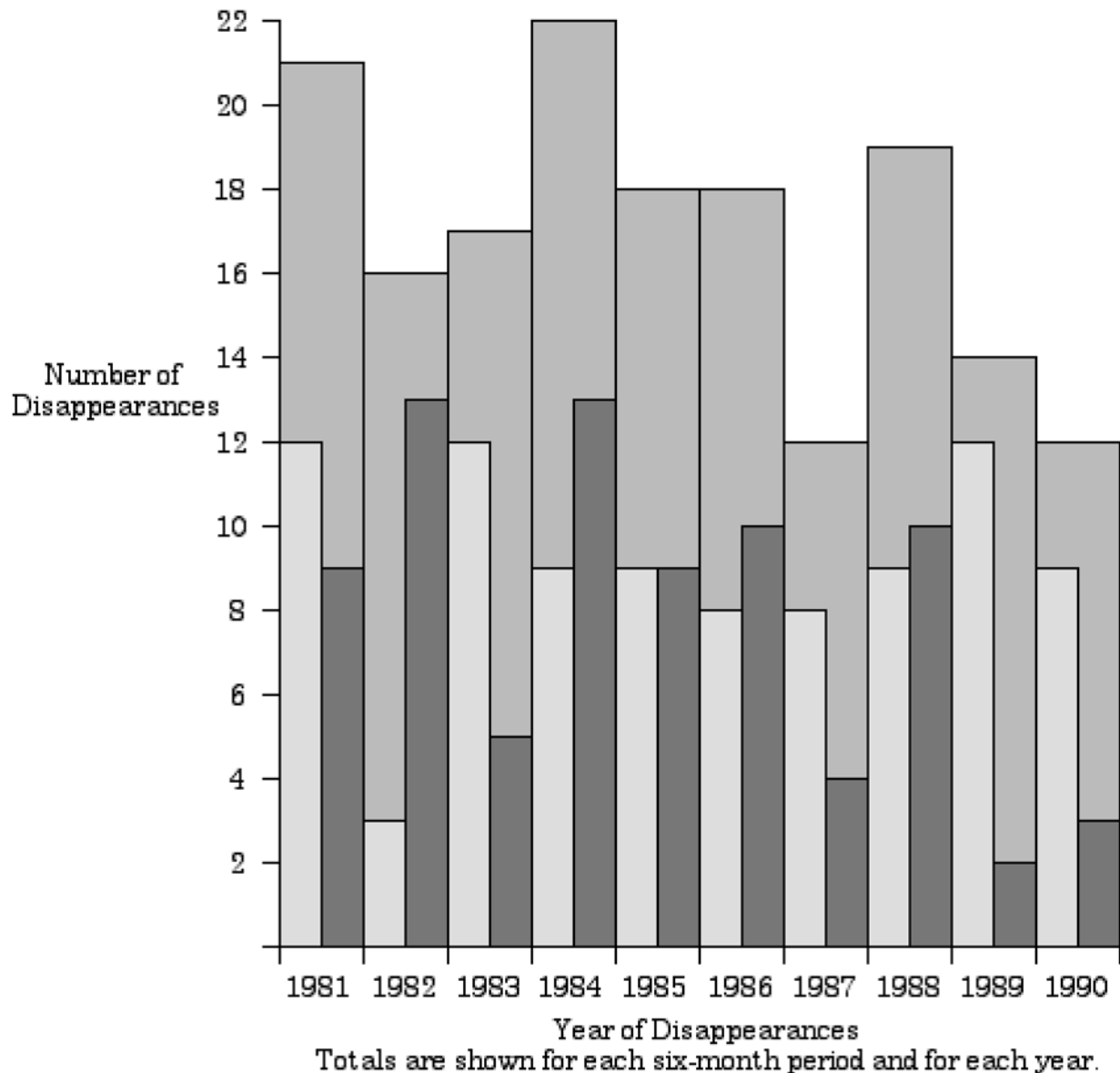

## Leonard Lake and Charles Ng:

### Disposal Camp

In the previous article, I proposed that Leonard Lake and Charles Ng had a lot of help. I didn't say what I thought was the source of that help. I have a theory. You might not like it but it explains the anomalies. If you can think of a better theory that explains the anomalies as well as my theory does, then you're welcome to propose it. Here's my theory. The help that Leonard Lake and Charles Ng received came from an unnamed agency within the U.S. government. Their job was to dispose of people for that agency. Consider the following statement by Donald H. Rumsfeld, from the same speech cited above.

There's a myth, sort of a legend, that money enters this building [the Pentagon —editor] and disappears, like a bright light into a black hole, never to be seen again. In truth, there is a real person at the other end of every dollar....

The unnamed agency theory also provides an explanation for another unexplained mystery relating to the attacks on September 11, 2001. Hopefully, I'll write about that next month. ☞

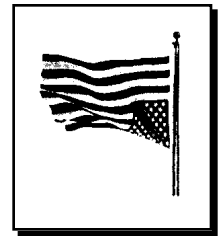
